Dr. Natasha C. Pratt-Harris is a Full Professor and the Director of the Graduate Program in the Department of Sociology, Anthropology, and (Criminology & Criminal Justice) in the College of Liberal Arts at Morgan State University in Baltimore, MD USA. She is the primary advisor for the inaugural cohort of the Applied Sociology and Social Justice PhD Program and the continuing Masters in Sociology Program. She is the founding Director of the Dubois-Diggs Center for Race and Social Justice in the College of Liberal Arts. She serves in Morgan's School of Social Work (split time between CLA and Social Work) for the newly established Interdisciplinary Center on Urban Crime. She is a scholar activist who is also a trained statistician and methodologist. For five cohorts (Fall 2018 - Fall 2022) Dr. Pratt-Harris has co-taught a Police and Society course based on a Policing Inside-Out Model (*Dr. Muhammad Experience*) where HBCU students, community members, and law enforcement are enrolled for 15 weeks to collectively address police-community relations. She is the Principal Investigator for the Community's Experiences and Perceptions of the Baltimore City Police Department Survey, as part of the BPD Consent Decree having published a comprehensive report Spring 2020 (Time 1 Data Collection Fall 2018 - Summer 2019) and Fall 2023 (Time 2 Data Collection Fall 2021 - Spring 2023). She is serving as the Principal Investigator for a National Science Foundation Build and Broaden 2.0 initiative - NSF Award Abstract # 2222512 Collaborative Research: Reimagining Policing by Making Neighborhoods Safe and Strong. She is the editor and contributing author for the textbook *Why the Police Should Be Trained by Black People* (published April 26, 2022 – Taylor and Francis Routledge Publishing) where she collaborated with more than thirty book contributors to address policing, crime, and community relations. Dr. Pratt-Harris has an earned Sociology PhD from Howard University. She is a product of K-12 public education in Baltimore City and earned bachelor's degree in Journalism and Criminology and Criminal Justice from the University of Maryland College Park and an earned master's degree in Criminal Justice Administration from the University of Baltimore.
